

The PSAI Flay & Glenda Anthony Volunteer of the Year Award

SUBMISSIONS DUE AUG. 7TH

The Flay and Glenda Anthony Volunteer of the Year Award is presented in any year where an individual or group has so distinguished themselves as to merit the praise and gratitude of the entire Association.

Awardees will have displayed the values of the PSAI, contributed in a meaningful way to the furtherance of its mission and goals, and been a positive example for others seeking to engage in the portable sanitation industry. Awardees may be recognized for focused, short-term involvement that produced a significant product or service. They may also receive the award as the result of their longer-term commitment to the PSAI that has resulted in accumulated goodwill and positive impacts on the lives of others.

Selection of this year's recipient will be based on the following criteria:

1. Displays the values of the PSAI
2. Contribution to the PSAI's mission and goals
3. Positive example for others to engage in the work of the organization

Guidelines and requirements:

- Open to PSAI volunteers active in the current fiscal year or active for multiple previous fiscal years
- Nominations submitted after August 7, 2026, will be returned for submission another year
- Nominators must be active volunteers with direct knowledge of the nominee's contributions
- Nominators must provide contact information for both the nominee and any persons submitting letters of support.
- It is not mandatory that your nomination be confidential, but it is customary. In order to preserve the good feelings of worthy nominees who may not be chosen this year, we ask that you respect this confidentiality and let the Awards Committee know if the nominee is aware of his/her nomination.
- Generally winners are not aware of their status in advance. Your assistance may be required in ensuring the winner is present in Daytona, FL, at the Awards Luncheon on Thursday, November 7th, 2026.

The nominating essay and all letters of support must be signed by the authors and submitted no later than August 7, 2026.
